House Energy and Commerce Committee Markup on Opioids Legislation and H.R. 4606, H.R. 5174, H.R. 5175, H.R. 5239, and H.R. 5240 May 9, 2018

On May 9, the House Energy and Commerce Committee held a markup of 26 bills to address the opioid misuse and overdose epidemic. The markup lacked the partisan divisions that occurred at the Health Subcommittee markup and all of the bills were reported by voice vote.

The Committee will meet on May 17 to consider additional bills, which are still being worked on. In his opening statement, Chairman Walden (R-OR) said, "upon completion of our markups this week and next, we will have fulfilled our commitment to report a package of bills to combat the opioid crisis to the House Floor by Memorial Day. I look forward to working with leadership to schedule floor action soon."

Democrats expressed concerns that the bills being considered today did not go far enough. In his opening statement, Ranking Member Pallone (D-NJ) said he supported the bills being considered today, but was concerned about some of the bills that were excluded from the markup process and cited a bill sponsored by Rep. DeGette (D-CO) on prior authorization for Medication Assisted Treatment (MAT) and a bill he cosponsored with Rep. Neal (D-MA) to expand access to coverage for Methadone under the Medicare program. Additionally, both Reps. DeGette and Castor (D-FL) said a full response to the epidemic is needed, similar to the Ryan White Act for the AIDs crisis.

He said he will introduce the amendment as a bill and Chairman Walden said the idea makes sense and committed to working with him to possibly incorporate the bill as they move the package to the Floor
- 7. HR 5197, Alternatives to Opioids (ALTO) in the Emergency Department Act as <u>amended</u>, reported by voice vote
- 8. HR 5261, TEACH to Combat Addiction Act of 2018, reported by voice vote
- 9. H.R. 5272, Reinforcing Evidence-Based Standards Under Law in Treating Substance Abuse Act of 2018, reported by voice vote
- 10. H.R. 5327, Comprehensive Opioid Recovery Centers Act 2018 as <u>amended/amended,</u> reported by voice vote

- a. The first amendment, offered by Rep. Guthrie (R-KY), clarifies that the services may be contracted out

She noted that the generic and Evzio versions have increased and said Evzio's price has gone up 500%. She also said that she thinks the Administration should be allowed to negotiate the price of naloxone and hoped the Committee will work on naloxone pricing as they continue to work on bills at next week's markup and going to the Floor.
