

House Ways and Means Committee
Markup of Bills to Combat the Opioid Crisis
May 16, 2018

On May 16, the House Ways and Means Committee held a markup of several bills addressing the opioid misuse and overdose epidemic.

While the markup was largely bipartisan, Democrats did raise some concerns. Rep. Kind (D-WI) said he was concerned about the lack of hearings prior to markup and Rep. Doggett (D-TX) was concerned that scores with the costs of the bills are not available from the Congressional Budget Office (CBO) and said that the changes in H.R. 5774 and H.R. 5775 could be accomplished administratively without requiring legislation. Additionally, as noted below, Doggett offered two amendments, both of which were tabled due to points of order. Ranking Member Neal (D-MA)'s opening statement is available [here](#).
